## **Grants Awarded to Lexington Area Nonprofits 2015 Grant Cycle Information Announced**

January 29, 2015 - The Lexington Area Community Foundation awarded grants totaling \$12,000 to eight nonprofit organizations in 2014. The organizations included:

**\$1,000** to **Arts Academy at Grace** for arts instruction classes for at-risk children.

**\$2,000** to Family Services of Davidson County, Inc. for interpretive services for non-English speaking individuals and families.

\$2,000 to J. Smith Young YMCA, Inc. for their STEM & LEGO Camp Experiences Programs.

**\$1,000** to Lexington Housing Community Development Corporation for a resource lunch and learn for military veterans & families.

\$1,200 to Path of Hope, Inc. to replace worn household items.

\$2.000 to Pastor's Pantry to restore senior food levels.

\$2,000 to Salvation Army of Davidson County for the Boys & Girls Club of Lexington Power Hour.

**\$800** to Smart Start of Davidson County for the Reach Out and Read Program.

The 2015 grant cycle will open July 20th and the deadline to apply is noon on August 31st. Funding interests will be announced closer to the cycle opening. The grant cycle will be conducted through a newly enhanced online application process. An Informational webinar is scheduled for March 4<sup>th</sup> at 3:00.
