

# Angel Donor Steps Up to give \$25,000 for Lancaster County; Second Challenge Announced

## First match met within 48 hours

LANCASTER, S.C.— On November 27, the J. Marion Sims Foundation announced a contribution of up to \$75,000 to the Lancaster County Community Foundation. Funds are dedicated to the work of the local community foundation, which focuses on strengthening the quality of life in Lancaster County, S.C.

The first \$40K of the J. Marion Sims Foundation pledge is targeted for 2018 grantmaking efforts by the Lancaster County Community Foundation in the following areas, noted as priority by both boards: Education, Health, Higher Education/Workforce Development, Human Services. An additional \$10K is dedicated to Arts & Culture, recently noted as an economic driver of the region. Within the original pledge, J. Marion Sims posted a \$25,000 challenge to the community, noting the Foundation's intention to provide dollar-for-dollar match for any additional contributions made to the Lancaster County Community Foundation, up to \$25,000, through March 2018.

Within 48 hours, the initial challenge of \$25,000 was met by a single donation to the Lancaster County Community Foundation by a family wishing to remain anonymous.

"We are blown away by the generosity of this angel donor," said Robert Folks, Board Chair, J. Marion Sims Foundation. "Our community will be impacted in perpetuity by this family's contribution to Lancaster County."

Inspired by this anonymous gift -- and to support those who might make additional year-end donations to support the community-- three local organizations have worked together to offer a second match challenge this week. Together, the partners are offering an extended dollar-for-dollar match (of up to \$17,500) for all gifts made to the Lancaster County Community Foundation through March 2018. These partners have a vested interest in the overall health and wellness of Lancaster County and are dedicated to supporting the quality of life for all residents.
