

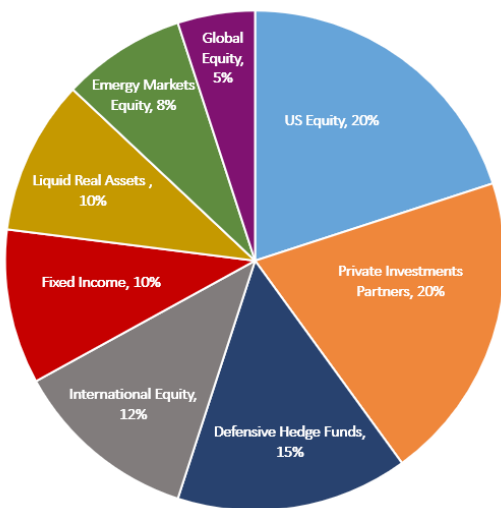

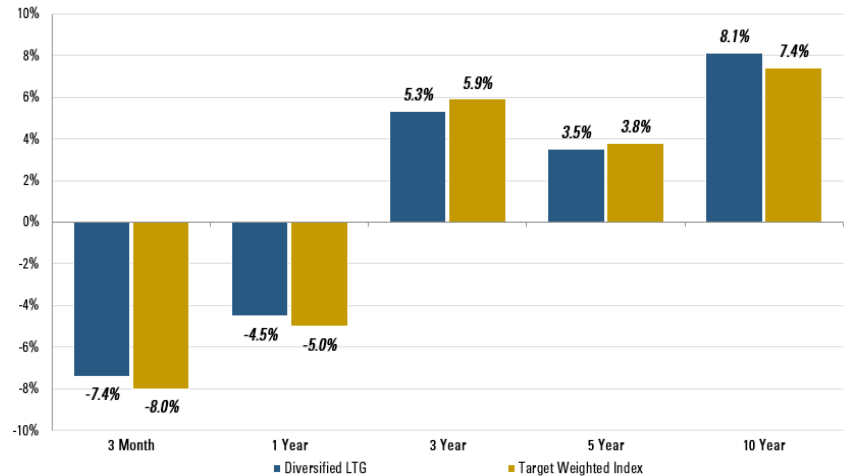


- ▶ Seeks capital appreciation with a long-term investment horizon through a broadly diversified growth-oriented portfolio
- ▶ Due to the illiquid nature of certain asset classes, certain liquidity terms apply if requesting more than 80% of the fund balance. See table below.

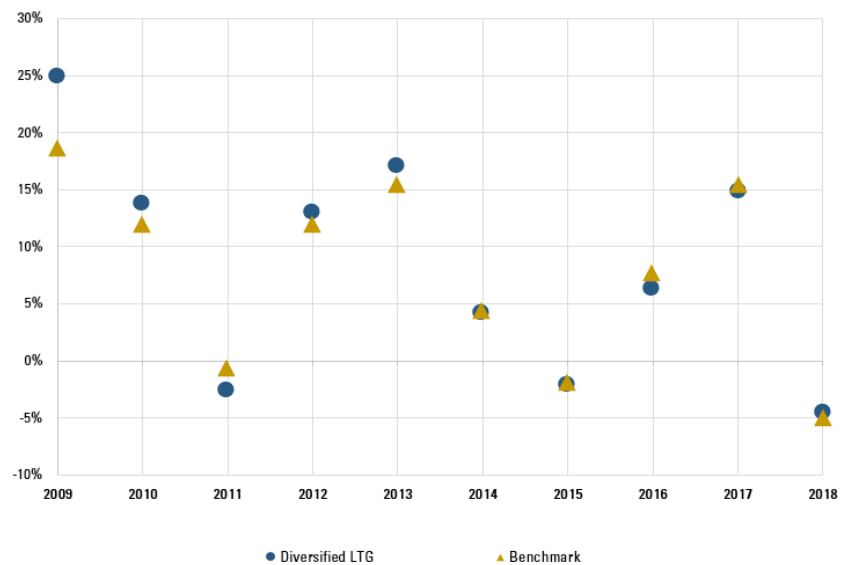
Target Allocations

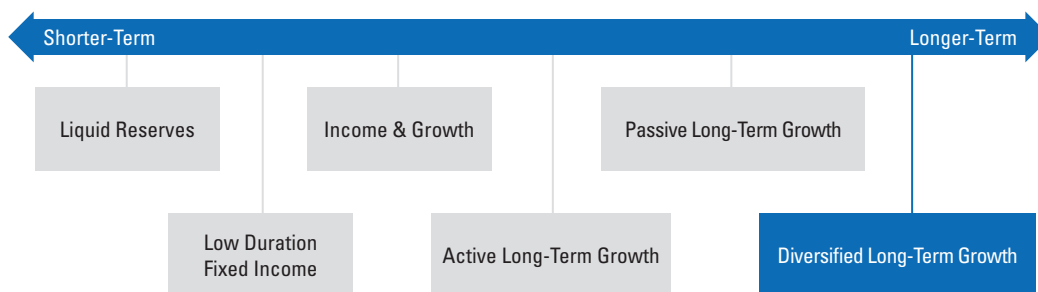
